This Standard required that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatements. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an opinion.
- 3. (i) Deferred tax assets/ liabilities for the quarter/half year ended December 31, 2015, required to be accounted for in terms of Accounting Standard (AS) 22 "Accounting for Taxes on Income" has not been determined or accounted for the by the Company, and therefore, its effect on results for the quarter/half year ended December 31, 2015 and earnings/ (losses) per share has not been determined. (Refer note (iii) of the accompanying statement)
 - (ii) The impact of Accounting Standard (AS) 15 "Employee Benefits" (Revised) issued by the Institute of Chartered Accountants of India has not been determined and accounted for the by the Company. Therefore its effect on the results for the quarter/half year ended December 31, 2015 and earnings/ (losses) per share has not been determined. (Refer note (iv) of the accompanying statement)

Further, we also report that we have traced the number of shares as well as the percentage of shareholding in respect of the aggregate amount of public shareholding and the number of shares as well as the percentage of shares pledged/encumbered and non-encumbered in respect of the aggregate amount of promoters and promoter group shareholding in terms of Clause 35 of the Listing Agreement with the Calcutta Stock Exchange and the particulars relating to undisputed investor complaints from the details furnished by the Management and therefore not expressing our review opinion thereon.
