गांव डेरा बाजीगर के हर घर में पानी, 35 परिवारों ने मंदिर में जमाया डेरा

कालाअम्ब और नाहन के पहाडों में अब भले ही बारिश थम चुकी हो और नदी का जलस्तर भी पहले से कम हो गया हो, लेकिन मारकंडा नदी का कहर अभी भी जारी है। पहले से जमा पानी का प्रवाह अब शाहाबाद और आसपास के निचले इलाकों में तबाही मचा रहा है। डेरा बाजीगर (पट्टी झामड़ा) में हालात बेहद खराब हैं। यहां हर घर में नदी का पानी घुस चुका है, जिससे करीब 35 परिवारों को घर खाली कर सुरक्षित स्थानों पर शरण लेनी पड़ी है। इनमें से कई परिवार अपने पशुओं समेत मारकंडा मंदिर के शेड के नीचे आश्रय लिए हुए हैं। गांव कठवा में हालात सबसे गंभीर बने हुए हैं। यहां शाहाबाद से जुड़ने वाली मुख्य सड़क पर 4 से 5 फुट पानी बह रहा है। पहले जहां लोग 2 से 3 फुट बहाव में निकलने की कोशिश कर रहे थे, अब वहां ट्रैक्टरों के फसलें पूरी तरह नष्ट हो चुकी हैं। सहारे ही रास्ता पार करना संभव हो पाया है। गांव के नुमाइंदों ने बच्चों
